


COVID-19 Good News: Teachers & Staff Going Above and Beyond



NYS Aid Revenue

- Unknown amount of additional reductions in NYS Aid/ revenue. Three assessment periods:
 - April 1 April 30
 - May 1 June 30
 - July 1 December 31

Budget Vote and Election Timeline

- May 11: Nomination petitions must be received by 5:00 p.m.
- May 12: Budget adoption
- June 2: Budget Hearing
- June 9: Election Day (absentee ballots only and must be received by 5:00 p.m.)

Voting Process

- Absentee ballots only.
- Must be received by 5:00 p.m. on June 9.

Board of Education Candidate

The Executive Order declared:

- Nominating petitions for candidates must be submitted to the District by May 11.
- Waived the requirement of signatures on nominating petitions.
- All age and residency requirements still remain applicable.
- The candidates must be listed on the ballot in alphabetical order.
- The absentee ballot must include a space for write-in candidates.





Revenue Sources

- *State Aid -usually finalized after the State Budget is adopted.
 - (Now capped at the Executive Budget Proposal or prior year aid (formula) whichever is less.)
 - * this year unknown amount of additional reductions in NYS Aid/revenue. Three assessment periods:
 - April 1 April 30
 - May 1 June 30
 - July 1 December 31
- <u>Tax Levy</u> Monies collected from district taxpayers via school tax bills
 - (Now limited by the Property Tax Cap Legislation.)
- <u>Local Non-Tax</u> Use of district reserves and miscellaneous revenues
- <u>Fund Balance</u> Unrestricted monies that can be appropriated into next year's budget

The State legislation, which requires the state's school districts to have a public budget vote, includes the requirement that the budget be divided up into three components: program, capital, and administration.

Three-Part Budget

- 1. <u>Administration Budget</u>: This section includes central administration and school offices, along with clerical support, salaries and benefits, and related expenses of all school administrators, board of education expenses for planning, legal expenses, and other administrative activities.
- 2. <u>Educational Program Budget</u>: This portion covers teacher salaries, school supplies, and all related educational costs.
- 3. <u>Capital Budget</u>: Refers to all facilities costs such as leases, annual debt service, custodial salaries and benefits, service contracts, custodial supplies, maintenance and repair of facilities, and utilities.





BUDGET VOTE & SCHOOL BOARD ELECTIONS

Voters are asked to decide upon two (2) propositions, in addition to the adoption of the proposed budget for the school year commencing July 1, 2020 and ending June 30, 2021, and to elect three Board of Education members.

PROPOSITION – THE BUDGET

Shall the Board of Education of the Mexico Academy and Central School District, Mexico, New York, be authorized to expend the sums of money, which will be required for school district purposes for the 2020-2021 School Year, in the total amount of \$57,619,200 (The Budget), and to levy the necessary sum against the taxable real property in the School District.

PROPOSITION I

Shall the Board of Education purchase and finance seven (7) student transportation vehicles at an estimated cost not to exceed \$710,000, including necessary furnishings, fixtures and equipment and all other costs incidental thereto and to expend a total sum not to exceed \$710,000, which is estimated to be the total maximum cost thereof. and levy a tax for the foregoing in the amount of \$710,000, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time or from time to time in the principal amount not to exceed \$710,000, and a tax is hereby voted to pay the interest on said obligations when due.

PROPOSITION II

Shall the Board of Education undertake a project consisting of renovations, reconfiguration and improvements to the Mexico Elementary School to create a School Based Health Center. including office space, storage area, restroom access, waiting area, MEP and security updates, related site improvements, original furnishings, fixtures and equipment (the "Project") and expend a total sum not to exceed \$525,000, which is estimated to be the total maximum cost thereof, using up to \$150,000 from the District's capital reserve fund and the levy of a tax upon the taxable property of the school district to be collected in annual installments in the years and in the amounts as the Board of Education shall determine and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time or from time to time in the principal amount not to exceed \$525,000, and a tax is hereby voted to pay the interest on said obligations when due.

Proposition 1 Mexico Elementary/ Mexico High School Shared Health Center Proposition

• In last year's budget proposal, we included a proposition to build the Mexico Elementary/ Mexico High School shared health center as a capital outlay project. We are very thankful that our voters approved this resolution.

• A Capital Outlay requires that the project be completed at a maximum \$100,000 cost **and** be completed with the school year it is approved for. Unfortunately, we are unable to meet these two requirements.

• However, we can again place it as a resolution to be approved by the voters for completion in the coming year. Additionally, we can complete this project with **no additional cost to taxpayers.**

Voters for District

Voters must possess the following qualifications to register:

- Be a citizen of the United States
- Be at least eighteen (18) years of age
- Be a resident of the District for a period of at least

30 days prior to the day of the vote

• Who is not otherwise ineligible to vote under the provisions

of section 5-106 of the Election Law

To be counted, correctly completed absentee ballots must be <u>received</u> in the Office of the District Clerk by 5:00 p.m. on June 9, 2020.
