

Summer school will take place at Mexico High School through a computer program called Grad Point. This is an on-line credit recovery program. Only students that were unsuccessful in passing a core course may register. Students sign up for one of two sessions (7/1-7/22 or 7/23 - 8/12) and will be in class either 8:00-11:00 am or 11:30-2:30pm. Students choosing to enroll in Summer school or retake a Regents need to complete the registration form and return it to the Student Services office at the HS in person or fax at 315-963-1921.

Transportation will not be provided to or from the school.

Online Summer Courses: Students going into their junior or senior year may choose to take a free college on-line course through Cayuga Community College. If you are interested, please call Student Services or stop by for an application. Deadline for registration is June 21st. Students should plan on attending the High School one day per week from July 10th through August 15th to work and consult with Distance Learning Teaching Assistant.

Testing Expectations

CELL PHONES AND ELECTRONIC DEVICES ARE PROHIBITED PLEASE REVIEW THE FOLLOWING POLICY

NEW YORK STATE EDUCATION DEPARTMENT POLICY Prohibition of Cell Phones and Electronic Devices in New York State Assessments

Students are prohibited from using cell phones and other communications devices while taking New York State assessments. The policy also prohibits all students from bringing cell phones and certain other electronic devices into a classroom or other location where a New York State assessment is being administered. Prohibited devices include, but are not limited to:

- Cell phones, BlackBerry devices and other PDAs
- IPods, MP3 players, iPads, tablets, and other eReaders
- Laptops, notebooks or any other personal computing devices
- Cameras or other photographic equipment
- Headphones, headsets, or in-ear headphones such as earbuds
- Any device capable of recording audio, photographic or video content, or capable of viewing or playing back such content.

Test proctors, test monitors, and school officials, shall have the right to collect cell phones and other prohibited electronic devices prior to the start of the test and to hold them while the test is being administered, including break periods. Admission to the test shall be denied to any student who refuses to relinquish a prohibited device.

This policy is effective immediately for all New York State assessments, including Regents Exams, Regents Competency Tests, Grades 3-8 Tests in English Language Arts and Mathematics, Grades 4 and 8 Science Tests, NYSESLAT, and the NYS Alternate Assessment.

Regents Exams are scheduled for 8:00 and 12:00. To allow sufficient time for giving directions and distributing exam materials, instruct students to be in their seats at least 15 minutes before test starting time (7:45 and 11:45).

The Uniform Statewide Admission Deadline is 10:00 a.m. for the morning session and 2:00 p.m. for the afternoon session. This means students are not permitted to hand in his or her test materials and leave the exam room before these times. Any student who arrives at the exam room before these deadlines must be admitted. Students who arrive after the deadlines, but who have been under the supervision of school personnel since the deadline should be admitted if the principal is certain that the student did not have an opportunity to exchange information with other students who had already left the exam. Latecomers are not generally entitled to have the closing time extended. However, if students started an exam late because of

extenuating circumstances beyond their control, the principal is permitted, but not required to authorize an extension of the closing time.
